

TERMS AND CONDITIONS SCHEDULE

Promotion: SCORE AT YOUR LOCAL STORE 2026 PROMOTION

Entry Restrictions: Entry to the Promotion is open to Australian residents currently living in Australia, aged 18 years and over who fulfil the entry requirements.

Directors, management, employees, officers and contractors (and their immediate family members) of agencies/companies directly associated with the conduct of this Promotion, the Promoter, businesses involved in determination of winner/s for the Promotion, businesses involved in the management of the Promotion, any organisation benefiting from the Promotion, the Promoter's distributors, suppliers, subsidiary companies/businesses and associated companies and agencies are not eligible to enter. "Immediate family member" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin

Promotion Period: Starts at 12:00am AEST on 19/08/26. Ends at 11:59pm AEDT on 06/10/26.

Entry Mechanic: To enter the Promotion, an entrant must complete the following steps during the Promotion Period:

- a) Purchase any two (2) Participating Products (defined below) from any IGA, Supa IGA, IGA X-Press, Drakes, Foodworks, Foodland, Supa Valu, Romeos, Friendly Grocer, The Local Grocer, Campbells, or any other independent grocery retailer that has Score At Your Local communication merchandised, within Australia during the Promotional Period (**Qualifying Transaction**); and
- b) Visit the Website www.scoreatyourlocal.com.au and follow the prompts to the promotion entry page. Entrants must agree to the Terms and Conditions herein and indicate that they are eligible to participate. On the promotion entry page, the entrant must register their details including:
 - i. Full name;
 - ii. Email address;
 - iii. Mobile phone number;
 - iv. Residential Address;
 - v. Store of purchase; and then
 - vi. Upload a photo or scanned copy of their receipt for the Qualifying Transaction purchased in accordance with the above requirements.

Entrants will find out instantly if they're a provisional winner (message reveal on screen). All Instant Win Prize claims are subject to verification. Entrants who are notified that they have won an Instant Win Prize will receive a Gift Card of the amount indicated on screen. Entrants who have not won a prize will receive a message on screen indicating that they are not a winner.

Entries are deemed to be received at the time and on the date that they are received by the Promoter. Each entrant must create their own entry and only submit an entry in their own legal name.

Participating Products: Includes any pack size or flavour variant of the following participating brands: Smith's, Doritos, Red Rock Deli, Twisties, Sunbites, Sakata, Nobby's, Popcorners, Cheetos, Obela, Solo or Solo Energy, Schweppes, Gatorade, Lipton, Pepsi or Pepsi Max, Mountain Dew.

Proof of Purchase: Entrants must retain their purchase receipt(s) for all entries as proof of purchase and may be required to validate and claim their prize. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant's entries and forfeiture of any right to a prize. Purchase receipt(s) must clearly specify the store of purchase and that the purchase was made during the Promotion Period but prior to the entrant submitting an entry into the Promotion.

Maximum Number of Entries: Multiple entries permitted subject to the following:

- a. A maximum of five (5) entries per person per day applies.
- b. One (1) entry is awarded for every two (2) Participating Products purchased in a single Qualifying Transaction, in accordance with these Terms and Conditions.
- c. A maximum of five (5) entries may be submitted per Qualifying Transaction, regardless of the total number of Participating Products purchased in excess of ten (10) in that transaction.
- d. Where a Qualifying Transaction includes more than two (2) Participating Products, entries will be calculated based on the total number of Participating Products purchased in that transaction (for example, four (4) Participating Products = two (2) entries; six (6) Participating Products = three (3) entries), subject always to the limits set out above.
- e. Each entry must be submitted separately and in accordance with the entry requirements set out in this Schedule and the Terms of Entry.

TERMS OF ENTRY

7. Any form of automated entry using any device or software is prohibited and will render an entry invalid.

Prize Draw

8. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
10. If an entrant is unable to or refuses or fails to take part in any element of this Promotion, or a winning entry is deemed not to comply with these terms, the Promoter reserves the right to discard that entrant's entry and proceed as if that entrant had not entered the Promotion.

Prize(s)

11. The winner(s) will be notified in accordance with the Notification of Winner(s).

12. The Prize(s) will be delivered to the winner(s) in accordance with the Prize Delivery. Once any prize has been issued to the email address of the Winner by the Promoter's (or supplier's), the Promoter will not be responsible for any delay in delivery, loss or damage to the Prize.
13. In the event of a Prize not being accepted or claimed, the Prize will be distributed in accordance with the Unclaimed Prize Allocation.
14. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) by any person in connection with this Promotion or accepting or using any Prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

23. Without limiting any other paragraph, the Promoter may at its discretion amend any aspect of this Promotion or of these terms, subject to applicable laws.
24. Nothing in these terms and conditions restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010* (Cth).
25. The information entrants provide will be used by the Promoter for the purpose of conducting this Promotion. By entering this Promotion, entrants consent to the storage of their personal information on the databases of the Promoter and its related bodies corporate and the Promoter and its related bodies corporate may use (where the entrant has opted in) this information for future promotional and marketing purposes regarding their products and services including (where the entrant has opted in) contacting entrants via electronic messaging. 27. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
28. In the event that there is a dispute concerning the conduct of the Promotion or claiming a prize, the Promoter will resolve the dispute in direct consultation with the complainant/entrant/winner. If the dispute cannot be resolved the Promoter's decision will be final.
